1 . Increased Limit - Residence Premises

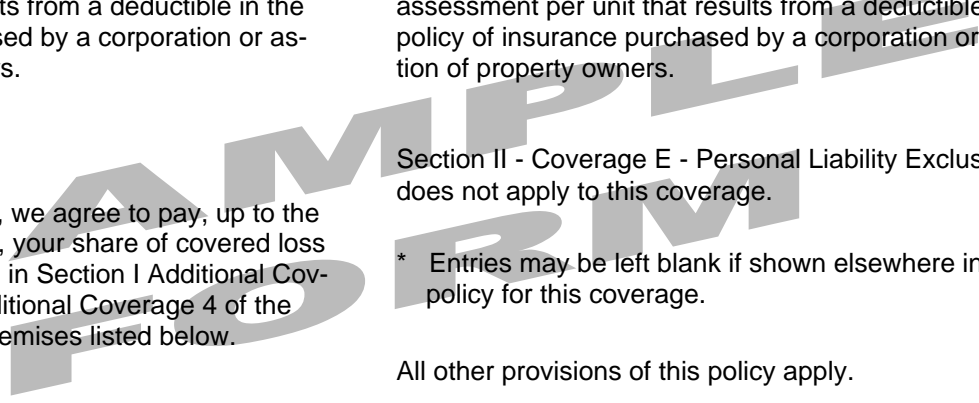
2 . Additional Locations
